The student and their parent or legal guardian assume all responsibility should any damage occur to the vehicle during the student's use of the vehicle.

The student agrees to pay Advantage Driving LLC the amount of \$_____ prior to the beginning of the class. ***Advantage Driving reserves the right to adjust price if "BTW" is not complete within 9 months of contract date.***
